EQUAL OPPORTUNITIES POLICY

WILCOT AND HUISH PARISH COUNCIL IS AN EQUAL OPPORTUNITIES EMPLOYER

Introduction

Wilcot and Huish (with Oare) Parish Council's intention is to be an effective Equal Opportunities organisation. This means it will do everything in its power to ensure that everyone has equal access, and is treated with respect, in relation to employment opportunities, to its services and to all its activities.

1. As an Employer

All employees are required to treat one another with mutual respect. Actions, behaviour and attitudes should consistently demonstrate respect for the dignity and worth of an individual, irrespective of the position they have within the organisation.

- 1.1 The Parish Council is making every effort to create a workplace where individuals are valued, listened to and treated with respect;
- 1.2 The Parish Council maintains a work environment that seeks out and values the insight, experience, contribution and full participation of all staff;
- 1.3 Harassment and discrimination in any form is unacceptable behaviour and offenders will be subject to disciplinary action.

2. As a Service Provider

The Parish Council will strive to ensure that all services provided by, or on behalf of, the Parish Council are made accessible to all individuals and groups equally and without discrimination;

- 2.1 All service users will be treated with respect. Actions, behaviour and attitudes should consistently demonstrate respect for the dignity and worth of an individual;
- 2.2 The Parish Council will, wherever appropriate, work in partnership with other agencies in the area, including the County and District Councils, voluntary groups and community organisations to promote equal opportunities;
- 2.3 The Parish Council will ensure that all contractors directly supplying goods and services or executing works for, or on behalf of, the Parish Council comply with this Parish Council's stated policy on equal opportunities.

The Policy in Action

3 As an Employer

The Parish Council aims to achieve the policy by:

- 3.1 Ensuring its employees are made aware of their rights and responsibilities to each other, the customer and the organisation regarding equal opportunities issues;
- 3.2 Providing a way in which individuals can communicate any concerns via competent named personnel;
- 3.3 Treating any unacceptable behaviour seriously;
- 3.4 Ensuring all Managers realise they have a key role in implementing this policy and are expected to take personal responsibility in ensuring its success;
- 3.5 Providing awareness training for all employees and Parish Councillors, ensuring opportunities to develop relevant competencies are available to implement the policy;
- 3.6 Meeting the commitments and living the aims of being a "Positive about Discrimination" employer.

4 As a Service Provider

The Parish Council aims to achieve its policy by:-

- 4.1 Providing training for all staff in equal opportunities awareness and customer care, emphasising equality of treatment in service delivery;

- 4.2 Ensuring that no member of the public is disadvantaged, or treated less favourably than others, in terms of access to Parish Council services. Where the Parish Council's practice, policy or procedures are found to make access impossible or unreasonably difficult, we will take such steps as are reasonable in the circumstances to change these practices, policies or procedures;
- 4.3 Ensuring that, wherever practical, all public buildings and premises owned or managed by the Parish Council are accessible to all. Where this is impractical in the short-term, we will provide reasonable alternative methods of access so that no member of the public is disadvantaged by physical barriers;
- 4.4 Recognising the importance of communication in attaining equity and quality services which are responsive to the needs of all local people, for example through the provision of information in large print and on audio tape on request;
- 4.5 Complying with all relevant legislation relating to discrimination and equity.

5 Role of Councillors and Employees

All Parish Councillors and employees are responsible for implementing the Parish Council's Equal Opportunities Policy. It is important that all individuals who are employed by the Parish Council appreciate that they have a responsibility and a role to play in the provision of equal opportunities.

6 Monitoring of Equal Opportunities

- 6.1 The Parish Council's Staffing Committee will have responsibility for the implementation and monitoring of the policy as it applies to The Parish Council as an employer, involving staff as appropriate in the monitoring process;
- 6.2 Complaints from staff about discrimination or unfair treatment will be dealt with as laid down in the Parish Council's Grievance Procedures;
- 6.3 Complaints from members of the public about discrimination or unfair treatment will be dealt with through the Parish Council's Complaints Procedure.

This Policy was approved and adopted by the Parish Council at a Meeting held on 19 November 2013, and will be reviewed annually.
